Madrasa Sultan-ul-Madaris & Jamia Sultania was founded in Lucknow by the Grand Ayatollah Syed Mohammad Abul Hasan (Abbu sahab) in 1892. This building was erected under the supervision of the Nawab Mehdi Hasan Khan, philosopher and philanthropist of Avadh. The foundation stone of this new building was laid on 1911 and after completion of the central hall it was inaugurated by Lieutenant Governor of the United Provinces, Sir John Prescott Hewett on 21st March 1913. Presently Maulana Mohammad Ishaq Rizvi is the principal of this prestigious institution and is taking great steps to revive its glorious past.
